2. This statement has been prepared in accordance with the Companies (Indian Accounting Standards) Rules, 2015 (Ind AS) prescribed under Section 133 of the Companies Act, 2013 read with rule 3 of the Companies (Indian Accounting Standard) Rules, 2015 and Companies (Indian Accounting Standard) (Amendment) Rules, 2016.

Due to change in tax rate applicable to the company from 34.944% to 25.17%, the deferred tax lability recognised in previous periods has reduced from ₹9421.33 lakhs to ₹7408.35 lakhs. Consequently deferred tax liability amounting to ₹2012.98 Lakhs has been reversed.

With respect to Inter Corporate loan advanced, the Company has executed security documents with the borrower for providing security by the borrower. Registration of charge will be completed within prescribed time. The wholly owned subsidiary of the company, Wintal Machines Srl., Italy, have been incurring losses since the last several years. While the losses are duly incorporated in the consolidated accounts for the period, the company has decided that the business of Wintal Machines Srl. would be run as division of the company.
